# From the President's Desk

### No Contract Settlement Yet

It is unfortunate that a settlement could not be reached on a new Labor-Management Agreement by March 31, 2023.

The Association and System continued to meet throughout April, and four sessions are scheduled in May (May 8, 15, 17, and 22). The goal, now, is to compete negotiations by June 16<sup>th</sup>.

Several of the System's proposals that are not in the teachers' best interest are still on the table. They include Salary, Medical, Grievance, the number of sections taught by part-time teachers, the accumulated sick day cap, as well as other significant changes in working conditions.

As talks continue, the ACT Team will work very hard to bring back a contract that you, the members, can accept. At present, that does not look promising.

Please continue to keep both Negotiating Teams in your prayers.



# **LEGISLATIVE UPDATE**

The following Legislative Report was submitted by ACT Legislative Representative, John Corrigan, at the ACT April Executive Board Meeting held via zoom on April 20, 2023.

#### March 2023

**Constitutional Amendment:** On February 23, the PA House passed (161-40) a proposed stand-alone constitutional amendment to provide a 2-year window in the statute of limitations for childhood sexual abuse victims. The House measure would have to be reconciled with the Senate combined bills passed earlier in order to be approved. The situation remains at an impasse.

**School Funding Court Decision.** The PA Commonwealth Court decision that found the school funding system to be unconstitutional was not appealed by the March 9 deadline.

**Governor Shapiro's Proposed Budget.** New Governor Josh Shapiro's first budget proposal includes an increase of \$567M (7.8%) in basic education funding, an increase of \$103M in special education funding, and additional funding for universal free breakfast, school safety and security grants, remediation efforts for environmental hazards, and tax incentives for new teachers.

#### **April 2023**

**US Supreme Court Decision. Perez v. Sturgis Public Schools** (March 2023): The Supreme Court unanimously sided with a student in a special education case (sign language interpreter) that involves the interplay between two different federal disability laws: ADA (American Disabilities Act) and IDEA (individuals with Disabilities Act).

**Special Elections:** Two PA House seats are scheduled for special elections on May 16, 2023: PA House District 108 – vacancy of Lynda Schlegel Culver (R); PA House District 163 – vacancy of Michael Zabel (D).

**PA Primary Election Day** is Tuesday, May 16, 2023. PA has a closed primary system.

# First Semester Evaluation Data Results

As I have said in previous newsletter articles, you always rise to all of the challenges you face in the classroom. I have applauded and continue to acclaim all that you have done and are doing for your students.

Now, the data from the First Semester Evaluations is further affirmation of all that you have accomplished during this school year.

97.18% of tenured teachers received a Distinguished or Proficient rating and, in the case of Guidance counselors, a Satisfactory rating from their administrative evaluator. 98.86% of tenured teachers received these ratings from their department heads.

85.64% of non-tenured teachers received a Distinguished or Proficient rating and, in the case of Guidance counselors, a Satisfactory rating from their administrative evaluator. 87.85% of non-tenured teachers received these ratings from their department heads.

What impressive statistics! Congratulations to each and every one of you!

We are now in the fourth quarter. There is just less than two months left in the 2022-2023 school year. The end is getting closer with each passing day. As exhausted as you may feel, you can do this! # Senior Delegate Elections (May 15<sup>th</sup> – June 1<sup>st</sup>)

*Teachers need an Advocate.* Do you have what it takes to be a Senior Delegate? If Social Justice in action, teacher dignity and respect are issues that you find important, and, if you would like to work with these issues, then consider running for Senior Delegate at your school.

### **Responsibilities Include:**

- 1. Act as a liaison between your members and administration.
- 2. Provide representation for your members in situations where any member reasonably feels that disciplinary action may occur.
- 3. File grievances to settle issues of opposing interpretations of the contract.
- 4. Encourage members to become familiar with and support the contract.
- 5. Conduct meetings at the local level.
- 6. Attend all meetings to represent your school.
- 7. Encourage your members to attend general membership meetings.
- 8. Keep the Executive Board informed of local issues.
- 9. Be responsible for conducting all union elections in the school.
- 10. Be responsible for the ACT Bulletin Board.
- 11. Distribute information from the ACT Office to the teachers.
- 12. Perform duties assigned to you by the Executive Board.
- 13. Be responsible for signing up new members and maintaining the good standing of present members.

#### Senior Delegates received a stipend of \$250 for the 2022-2023 school year.

## SENIORITY LISTS POSTED (for school only)

Article V, Section 1b states "On or before April 1 of each school year, the Secondary School System shall supply to the Association and shall post in each school a complete listing of all full-time teachers in that school including those on approved leaves of absence arranged according to school seniority." "Teachers shall have until **May 1** to call attention in writing to errors or file grievances with the local school administration concerning their positions on the seniority roster."

Bishop Shanahan Math teacher, John DeSantis, and his Collie, Ingrid, are once again in the news. The *Spirit* of '76 first brought you their story in the February 2022 edition, after John and Ingrid's story appeared in the *Chester County Daily Local* and was featured on ABC's show, *Localish*.

At that time we learned that John adopted Ingrid in 2019 after her previous owners were unable to keep her due to Ingrid's health problems and the expensive medical procedures needed to treat them. John nursed Ingrid back to good health, after getting her the care she needed.



He later enrolled Ingrid in training classes, where she

completed five levels of training and became a certified therapy dog. John was and is often seen visiting nursing homes, schools, and senior centers with Ingrid. Together they have made more than four hundred visits to bring comfort and joy to those suffering from loneliness, stress, and anxiety.

Recently, John attended the Collie Club of America (CCA) Convention held in Indiana, where collies were being recognized for their achievements in their fields of training and service.

The highlight of the gathering was to honor dogs and their handlers who made outstanding contributions of service in the following categories: Therapy, Search and Rescue, Protector, Library/Reading and Trauma Response with the "Shining Star Award."

John and Ingrid were presented with the prestigious "Ambassador Award," which is presented to one team from around the world that excels in service and best represents the ideals of the collie breed.

As the 2023 CCA Ambassador team, John and Ingrid will continue their mission to advocate for the benefits of pet therapy and bring comfort and companionship to the people with whom they visit.
