

LEGISLATIVE UPDATE

The following Legislative Report was submitted by ACT Legislative Representative, John Corrigan, at the ACT April Executive Board Meeting held via zoom on March 21, 2024.

Legislative Update

House Bill 2036 (H.B. 2036): EITC & OSTC Funding. On February 27, 2024, PA Representative Joe Ciresi (D-Montgomery County: Pottsgrove, Pottstown, Spring-Ford), along with 17 cosponsors, has introduced legislation with the potential to have a significant impact on the Educational Income Tax Credit (EITC) and Opportunity Scholarship Tax Credit (OSTC) programs. According to Voter Voice of the PA Catholic Conference, this bill would have detrimental effects on parental choice in education in PA in the following ways:

- Cut family income limits for students participating to 200% of the federal poverty level (This would cut the current family EITC & OSTC eligibility in half).
- Eliminate support level factors for families with students with a disability.
- Impose new reporting requirements on scholarship organizations to report data on every student given a scholarship, and for every applicant who was "denied."
- Impose new reporting requirements on schools--affecting every nonpublic school in the State.
- Give the State discretion to impose new reporting requirements without legislative approval.

Voter Voice is encouraging all those who support the EITC and OSTC programs to contact their elected officials.

PA Student Teacher Support Program

State Senator Vincent Hughes (D-Philadelphia; Appropriations Chair) recently promoted the new \$10 million investment secured through his legislation (Senate Bill 300 - 2023) to provide up to \$15,000 stipends for student teachers in PA through PHEAA. Senator Hughes cited a 71% decline in teacher certifications from 2011-2022. Senator Hughes also said he will be advocating for Governor Shapiro's \$15 million budget proposal this year.

Education Developments

PA Rep. Thomas Kutz (R) and Rep. Justin Fleming (D) are teaming up to introduce a bipartisan bill to require the Pennsylvania Department of Education to create a comparison tool on its website that would allow high school students to compare costs of college options which can often be a challenge. The motive is to make sure high school students have all the information available to make such a big financial decision as college selection.

In the recent SOTU Address, President Joe Biden advocated for raising teacher pay and increasing access to early childhood education, and he highlighted his administration's efforts to promote tutoring, summer learning, and career and technical education.

The U.S. Department of Education is likely to finalize two key Title IX proposals related to federal anti-discrimination laws. Changes to implementation include shortening investigation and resolution timelines.

FORMER LONGTIME ACT PRESIDENT AND RETIREE IN THE NEWS

On Friday, April 12, 2024, retired ACT Member and former long-time ACT President, Rita C. Schwartz, was honored by the Catholic Education Special Interest Group (SIG) of the American Educational Research Association (AERA) for her extraordinary service to Catholic education in Philadelphia and the United States.

The Catholic Education SIG is a group of researchers and educators who support, promote, and disseminate information, research, and evaluation of Catholic education. "As a professional organization, we value the distinct gifts of Catholic school teachers and the mission of Catholic schools, which you have dedicated your life to supporting. We recognize that your years of work organizing teachers in Catholic schools embodies the call of Catholic Social Teachings to uphold the dignity of work and rights of workers."



Rita began her career in the Archdiocese of Philadelphia in 1963 when she accepted a teaching position at St. Hubert Catholic High School for Girls. She was actively involved in the formation of the Association of Catholic Teachers and became President of the Association in 1984. Rita remained President for the next 36 years, negotiating sixteen contracts, and helping teachers across the Archdiocese of Philadelphia.

Rita was also President of the National Association of Catholic School Teachers for 28 years. As President, Rita helped teachers across the United States form unions at their schools or in their dioceses. Rita has always fought for social justice for all Catholic school teachers.

Rita retired from the Association of Catholic Teachers in December of 2020. In December of 2023, Rita retired from the National Association of Catholic School Teachers, and is now enjoying a well-deserved rest.

Congratulations, Rita, on your Award! The recognition is well-deserved! Teachers everywhere are thankful for your guidance, leadership, and your dedication to social justice for Catholic school teachers everywhere.

Senior Delegate Elections (May 15th – June 1st)

Teachers need an Advocate. Do you have what it takes to be a Senior Delegate? If Social Justice in action, teacher dignity and respect are issues that you find important, and, if you would like to work with these issues, then consider running for Senior Delegate at your school.

Responsibilities Include:

- 1. Act as a liaison between your members and administration.
- 2. Provide representation for your members in situations where any member reasonably feels that disciplinary action may occur.
- 3. File grievances to settle issues of opposing interpretations of the contract.
- 4. Encourage members to become familiar with and support the contract.
- 5. Conduct meetings at the local level.
- 6. Attend all meetings to represent your school.
- 7. Encourage your members to attend general membership meetings.
- 8. Keep the Executive Board informed of local issues.
- 9. Be responsible for conducting all union elections in the school.
- 10. Be responsible for the ACT Bulletin Board.
- 11. Distribute information from the ACT Office to the teachers.
- 12. Perform duties assigned to you by the Executive Board.
- 13. Be responsible for signing up new members and maintaining the good standing of present members.

Senior Delegates received a stipend of \$250 for the 2023-2024 school year.

SCHOOL SENIORITY LISTS POSTED

Article V, Section 1b states "On or before April 1 of each school year, the Secondary School System shall supply to the Association and shall post in each school a complete listing of all full-time teachers in that school including those on approved leaves of absence arranged according to school seniority." "Teachers shall have until May 1 to call attention in writing to errors or file grievances with the local school administration concerning their positions on the seniority roster."
