NEGOTIATIONS 2018: GETTING TO THE BARGAINING TABLE

If it's March, it must be Negotiations. Unfortunately, that has been our mantra for the past four years.

There is no one who dislikes a one-year contract more than I do. My reality, however, is that a multi-year contract cannot be brought back to you, the members, unless it provides sufficient salary increases while keeping medical premiums in check. It is equally important to ensure that the other nineteen Articles of the Labor-Management Agreement, especially those providing for your job security and fair treatment, remain intact.

Now that your Contract Surveys have arrived at the ACT Office and we know what you, the members, want in the next Labor-Management Agreement, the ACT Negotiating Team will begin putting it all together. Speaking of the ACT Negotiating Team, they were selected by the Executive Board at its February 27 Meeting. I am very happy to have Irene Tori, Tom Imburgia and Theresa Lazorko joining me at the bargaining table once again.

As soon as the Proposal is completed, we will present it to you, the ACT members, at a General Membership Meeting.

After our down-to-the-wire contract settlement last September, ACT had hoped for an Early Bird this year. However, our request was not acceptable to the System. Instead, the System wants contract talks similar to last year's, which ended at 6:30 A.M. on September 5, the opening day of the school year. At the same time, the System tells us it is committed to working with us to complete an early settlement. Confused? I certainly am.

To add to the confusion, when I ask to set an opening date for negotiations, which I have on several occasions, I am told that they will get back to us when they are ready.

Please be assured that once we get to the table, the ACT Negotiating Team will do all that it can to negotiate in good faith an Agreement that will provide for you, our members, fair and just working conditions and a salary increase and medical premium that you find acceptable.

HEART

It is always good to go back to the place where you worked, especially when you are retired! I went to the school I taught in for 41 years for an end of the year lunch.

But it was an experience that wasn't just about that day.

The past, present and future was what I experienced.

I walked in the front door to be greeted by a student I had taught a few years ago who was also back for the lunch. I was immediately put into teacher mode.

Teachers know exactly what I mean.

I walked a little bit down the hall, and I went through a time portal. It carried me to 1974. I passed a room that used to be the classroom of a teacher that became my best friend. We shared our pasts with each other as we talked every day.

She became the love of my life, my wife. I saw her for a moment in front of the classroom as I passed the open door. We have shared 41 years together.

I passed a room where class was just ending. I looked in at the future of our country. The eagerness of the students as they hurried to finish their assignment. That same room was where I was teaching when I got a phone call from my wife that she was in labor. I didn't finished that class but began another chapter in our lives.

That same day happened again when my second child was born two years later.

I walked upstairs and was greeted by a teacher that I had known for a long time. He was about to retire. I saw the past in his face, the present in his speech, and the future in his step. A few doors down, I looked in a room and I saw two young children.

It was the room where I brought my children when my wife had to work, and we had no other choice. It was nice of the school to allow this.

I looked again into the room and they were gone.

The room where I actually taught my daughter.

I closed my eyes and saw in my mind that little girl sitting there.

I hope she was proud of her father in front of the classroom.

I met a few of the people that were retiring this year and they told me of their future plans. I smiled and said that they should not forget the past and live in the present.

And I remembered the day I retired, like yesterday. Then I looked forward.

As I was leaving, I passed a stairway leading upstairs. I heard the voices of two children, one very young. I ran to the first room at the top of the stairs and remembered the day

I brought my first grandchild to school. She sat there all day, better than some of the teenagers I was teaching. Quickly I ran down the hall to the smart board I had taught on in my last few years. And there I pictured my second grandchild, barely able to reach the ledge, writing ABC on the white surface.

Yes my family had been tied to my job, but in reality my family was the beating heart behind my teaching.

I walked out the door, glancing back for a second, then driving home and into the family I love...and the future.


ACT WEBSITE
